SUBJECT: AUTHORITY TO CONDUCT AND ATTEND DA-BAFS TV VIDEO SHOOTS OF THE DEPARTMENT OF AGRICULTURE - BUREAU OF AGRICULTURE AND FISHERIES STANDARDS TECHNICAL SERVICES DIVISION (DA BAFS-TSD) RELATED TO PHILIPPINE NATIONAL STANDARDS (PNS) PROMOTION FROM MARCH TO SEPTEMBER 2024
