SUBJECT: DA MEMORANDUM CIRCULAR (MC) NO. 12, SERIES OF 2024

ENTITLED, "AMENDMENT OF DA MC NO. 48, SERIES OF 2023 OR THE REVISED IMPLEMENTING GUIDELINES FOR THE DISTRIBUTION OF NATIONAL RICE PROGRAM - FERTILIZER

**ASSISTANCE FOR FARMERS"** 

The DA-BAFS informs the public that the DA MC No. 48, series of 2023 (dated October 27, 2023) entitled, "Revised Implementing Guidelines for the Distribution of National Rice Program - Fertilizer Assistance for Rice Farmers", was amended through DA MC No. 12, series of 2024 (dated April 8, 2024). Salient points of both Circulars that concern the DA-BAFS' registered organic inputs are as follows:

- 1. **Biological fertilizers (biofertilizers) or microbial inoculants** shall be **DA-BAFS-registered**;
- 2. DA-Regional Field Offices (RFO) shall **pre-qualify all biofertilizers or microbial inoculants interested in participating in the biofertilizer project**;
- 3. **Foliar fertilizers are not considered** under the project; and
- 4. These fertilizers must have **undergone fertilizer debris/trials/studies and participated in technology/field demonstrations** conducted by the DA-Philippine Rice Research Institute (PhilRice); DA- RFO; International Rice Research Institute (IRRI), or any research institution.
