- v. Client steps and agency actions to obtain a particular service;
- vi. Person responsible (in designation) for each step; and
- vii. Processing time per step and total.
- c. Procedure for filing complaints and feedback; and
- e. List of Offices.
- 5) The Citizen's Charter Information Billboard is posted at the office lobby, near the main entrance of the office.
- 6) The printed Citizen's Charter Handbook is placed at every office to complement the information on the services indicated in the Information Billboard.
- 7) The Citizen's Charter Handbook version is uploaded on the website of the agency through a tab or link specifically for the Citizen's Charter, located at the most visible space or area of the official website.
- 8) The Citizen's Charter is written in English.
- 9) There is an established Client Satisfaction Measurement Tool per service.
